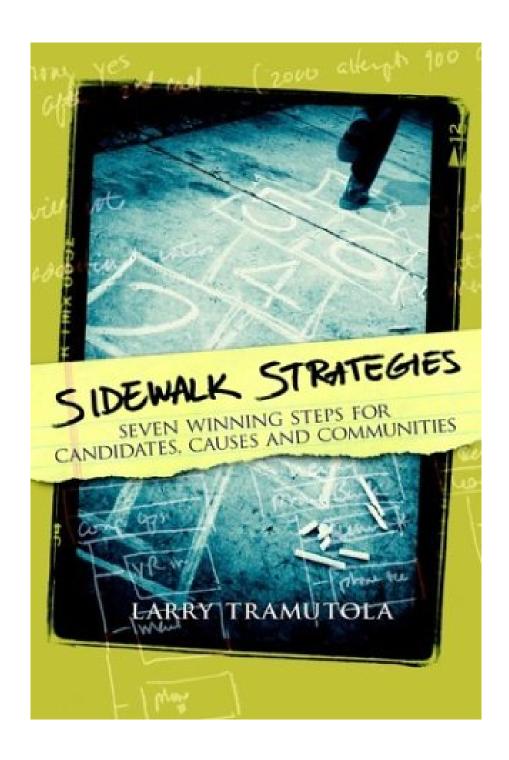

In 2006 our local school district had its first bond election in over 30 years, in a very conservative area. 70% of the population had no school age kids. (Lots of retirees and empty nesters.)
